Part A: Pupil premium strategy plan

Statement of intent

What are your ultimate objectives for your disadvantaged pupils?

To ensure that all children eligible for the Pupil Premium Grant make good academic and social progress across the school, irrespective of their background or the challenges they face, including progress for those that are already high attainers.

We recognise that high-quality teaching is a key component to enable schools to improve outcomes for disadvantaged pupils. We therefore offer an education which is challenging, exciting, cross-curricular, investigative and knowledge rich. We will have succeeded if our pupils demonstrate independent learning, readiness for life and are given the chance to achieve the best results possible.

How does your current pupil premium strategy plan work towards achieving those objectives?

Overcoming barriers to learning is at the heart of our Pupil Premium Strategy. We use evidence-informed research to make decisions on the best approaches for all our pupils. By identifying key barriers to success for children and seeking to put in place realistic and effective solutions to overcome them our pupil premium strategy works to achieve our ultimate objectives for our disadvantaged pupils as outlined above. These decisions are regularly reviewed to ensure that they remain effective and maximise progress for all disadvantaged pupils.

What are the key principles of your strategy plan?

Recognising that all children are unique individuals and that to best support them we must look academically at individual strengths, difficulties and characteristics and further to be able to offer support for emotional and mental wellbeing where needed.

Ensuring all pupils have access to High Quality Teaching and Learning. The intention is that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers. In this vein, we will continue to work with Wensum Literacy Hub via Read, Write Inc (RWI) tailored follow-up support, who have been funded by the DfE, to aid schools to achieve excellence in teaching reading and early language development.

Providing targeted academic support for pupils who are not making expected progress, and this will be rooted in robust diagnostic assessment eg RWI, tutoring lowest achieving 20%. Individual staff discussions will also take place through Pupil Progress Meetings.

Addressing non-academic barriers to learning such as attendance, behaviour, mental health and adverse childhood experiences/trauma.

Working with parents to ensure that children have the necessary resources/support for learning and are given opportunities to participate in extra-curricular activities, school trips and residential visits. This is particularly important with the number of service children that we have in the school where children can be in a 'single-parent' households for long periods of time.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	The social, emotional and wellbeing of many of our disadvantaged pupils have been impacted by significant absence (including the absence of staff who deliver interventions) to a greater extent than for other pupils. These findings are supported by national studies and there has also been an increase in school-based referrals as well as pupils receiving small group interventions. This is also exacerbated by high mobility rates at our school because of the number of service pupils we have from Robertson Barracks.
2	Assessments and observations in KS1 (particularly Yr1) suggest disadvantaged pupils generally have greater difficulties with phonics (RWI) and reading than their peers. This can impede their development as readers and writers.
3	Internal assessments indicate that Maths and English attainment/ progress among some disadvantaged pupils is below that of non-disadvantaged pupils.
4	Underdeveloped oral language skills and vocabulary gaps (as well as basic general knowledge). These issues are particularly evident in KS1 and in general, are more prevalent among our disadvantaged pupils than their peers.

Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

Improved wellbeing for our disadvantaged pupils to help them to be resilient and more successful/aspirational	Impact of nurture-based interventions show that children are happier and more engaged with school – teacher observations in class, parent feedback, pupil voice interviews. Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in 2022/2023 academic year.

Our internal and external assessments during 2022/23 suggested that the performance of disadvantaged pupils has improved in many key areas of the curriculum and is broadly in line with non-disadvantaged pupils. Absence during this academic year has decreased which has had a positive impact on delivery of the curriculum and the outcomes we aimed to achieve in our strategy by the end of 2022/23.

Our assessment of these outcomes' shows that the impact of Covid-19 has now lessened which has caused much less disruption to our curriculum. As evidenced in schools across the country, pupil/staff absence was most detrimental to our disadvantaged pupils so the fact this has significantly improved has meant that our pupil premium funded improvements to teaching and targeted interventions have had much more of an impact. Yr6 SATs results were outstanding, including for disadvantaged pupils. However, the end of year data in EYFS and KS1 was lower than expected (including for disadvantaged pupils) and is a major focus which we are addressing through our SIDP and spending priorities in 2023/24.

Observations and internal assessments indicated that pupil behaviour, wellbeing and mental health continued to improve last year with disadvantaged children benefitting from spending more time in school overall. We used pupil premium funding to continue to provide wellbeing support and targeted interventions where required. We continue to build on this approach with the activities detailed in the plan above for 2023/24 e.g. PATHS Programme

How did you spend your service pupil premium allocation last academic year?	<p>The service pupil premium (£17,085) was an integral part of the Targeted Academic support and Wider Strategies that were put in place across the school (see above).</p> <p>Service pupils were specifically supported by designated members of support staff (as well as continuing to be supported by the whole school community as they have always been) ensuring successful transitions into the school and between classes.</p> <p>The support provided is tailored to children/ family members, and includes:</p> <ul style="list-style-type: none">• A daily Lunchtime Club where service children can have access to a safe place where they can play and receive pastoral support if required
